**Subject: Newspaper notice for transfer of equity shares to Investor Education and Protection Fund (IEPF) Authority**

Pursuant to the provisions of Section 124(6) of the Companies Act, 2013 read with Rule 6 of the Investor Education and Protection Fund Authority (Accounting, Audit, Transfer and Refund) Rules, 2016, as amended, Equity Shares in respect of which dividend has not been claimed for seven consecutive years or more shall be transferred to Investor Education and Protection Fund ('IEPF'). Accordingly, Bandhan Bank Limited (the '**Bank**') is required to follow certain process before such transfer including publishing notice in the leading newspaper in English and regional language having wide circulation informing the concerned shareholders that their names and folio number/ DP ID - Client ID are available on the website of the Bank duly mentioning the website address.

### **NOTICE TO SHAREHOLDERS**

(For Transfer of Equity Shares of Bandhan Bank Limited to Investor Education and Protection Fund)

**NOTICE** is hereby given in compliance with the provisions of the Investor Education and Protection Fund Authority (Accounting, Audit, Transfer and Refund) Rules, 2016, as amended, and various circulars issued thereto, from time to time, by the Ministry of Corporate Affairs (collectively referred as 'IEPF Rules')

Further, it may be noted that pursuant to the amalgamation of GRUH Finance Limited ('GRUH') into and with Bandhan Bank Limited (the 'Bank') with effect from October 17, 2019, all the claims relating to dividend declared by erstwhile GRUH shall be made with the Bank.

In terms of the provisions of Section 124(6) of the Companies Act, 2013, read with IEPF Rules, the Bank is required to transfer all shares, in respect of which, dividend has not been paid or claimed for seven consecutive years or more, to the demat account of the Investor Education and Protection Fund ('IEPF') Authority. Accordingly, equity shares in respect of which, dividend declared for the financial year 2015-16 and onwards remains unpaid or unclaimed till July 21, 2023 shall be transferred to the IEPF Authority. However, where there is a specific order of any Court or Tribunal or Statutory Authority restraining any transfer of such shares and payment of dividend or where such shares are pledged or hypothecated under the provisions of the Depositories Act, 1996, the Bank will not transfer such shares to the IEPF Authority.

**NOTICE** is further given that in accordance with the provisions of the IEPF Rules, individual notices have already been sent to the concerned shareholders, at their latest addresses available with Bank/KFin Technologies Limited [the Registrar and Share Transfer Agent ('RTA') of the Bank], inter alia, providing relevant details of shares due to be transferred to the IEPF Authority. The details of such shareholders, such as, names of such shareholders and their folio number or DP ID-Client ID, is also available on the website of the Bank under the section 'Investor Relations' at <https://bandhanbank.com/unclaimed-shares>.

The concerned shareholders are, therefore, requested to claim the unpaid or unclaimed dividend(s) on or before July 21, 2023, failing which, their shares, along with the benefits accruing on such shares, will be transferred to the IEPF Authority.

The concerned shareholders, holding shares in physical form and whose shares are liable to be transferred to IEPF Authority, may please note that in terms of the IEPF Rules read with SEBI Circular dated January 25, 2022, the Bank would be issuing Letter of confirmation in lieu of the original share certificate(s) held by them for the purpose of transferring the said shares to IEPF Authority and the said original share certificate(s) shall automatically stand cancelled. After issue of Letter of Confirmation, the Bank will inform the depository by way of corporate action to convert such physical share into DEMAT form and transfer in favour of the IEPF Authority. Further, in case of shares held in demat mode, the transfer would be effected by way of a corporate action to be executed with the concerned depository with necessary instruction to transfer such shares directly to IEPF Authority. The concerned shareholders are further requested to note that all future benefits arising on such shares would also be transferred to the IEPF Authority.

It may further be noted that post transfer of shares and dividend to IEPF Authority, the concerned shareholder may claim the shares and dividend so transferred from the IEPF Authority by making an online application in the prescribed Web based e-Form IEPF-5 and thereafter, sending the physical copy of the same, duly signed (as per the specimen signature recorded with the Bank), along with requisite documents as enumerated in the e-Form IEPF-5 and IEPF Rules, in original, to the Bank/RTA at the addresses mentioned below. The Shareholder are requested to refer the procedure prescribed under the IEPF Rules or visit website of IEPF authority at [www.iepf.gov.in](http://www.iepf.gov.in).

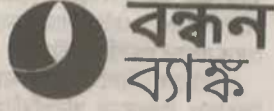

(ইনভেস্টর এডুকেশন অ্যান্ড প্রোটেকশন ফান্ড বন্ধন ব্যাঙ্ক লিমিটেডের ইকুইটি শেয়ার হস্তান্তর ট্রান্সফার করার জন্য)

এতদ্বারা ইনভেস্টর এডুকেশন অ্যান্ড প্রোটেকশন ফান্ড অথরিটি (হিসাব, অডিট, হস্তান্তর এবং ফেরত) আইন, 2016-এর বিধান অনুসারে, এবং মিনিস্ট্রি অফ কর্পোরেট অ্যাফেয়ার্স দ্বারা পরিবর্তিত ও সংযোজিত তৎসহ ভিন্ন ভিন্ন সময়ে জারি করা বিভিন্ন সার্কুলারের বিধান (সম্মিলিতভাবে 'IEPF আইন' রূপে অভিহিত) মেনে এই বিজ্ঞপ্তি জারি করা হচ্ছে। এছাড়া, এটাও লক্ষ্য করা উচিত যে, গৃহ ফাইন্যান্স লিমিটেড ('GRUH') এবং বন্ধন ব্যাঙ্ক লিমিটেড (অতঃপর ব্যাঙ্ক হিসেবে উল্লেখিত)-এর একত্রী করণ প্রকল্পের কার্যকারিতা মেনে নিয়ে 17 অক্টোবর, 2019 থেকে গৃহ দ্বারা ঘোষিত ডিভিডেন্ড সম্পর্কিত যাবতীয় দাবি এখন থেকে ব্যাঙ্ক দ্বারা নির্ণয় করা হবে।

IEPF নিয়মের সঙ্গে পাঠ্য, কোম্পানি আইন, 2013, ধারা 124(6)-এর বিধান অনুযায়ী, ব্যাঙ্ক সেইসব শেয়ার হস্তান্তরিত করবে ইনভেস্টর এডুকেশন অ্যান্ড প্রোটেকশন ফান্ড ('IEPF') কর্তৃপক্ষকে যার সাপেক্ষে শেয়ারহোল্ডাররা পরপর 7 বছর বা তার বেশি সময় কোনও ডিভিডেন্ড প্রাপ্ত হননি বা দাবি করেননি। তদনুসারে, আর্থিক বছর 2015-16 থেকে 21শে জুলাই, 2023 পর্যন্ত ইকুইটি শেয়ারের ডিভিডেন্ডে ঘোষিত না-দেওয়া বা দাবি না-করা ডিভিডেন্ড রাশিটি IEPF কর্তৃপক্ষকে হস্তান্তরিত করা হবে। তবে যদি কোথাও কোনও কোর্ট, ট্রাইব্যুনাল বা সংবিধিবদ্ধ কর্তৃপক্ষ (স্ট্যাচুটেরি অথরিটি) দ্বারা এই জাতীয় শেয়ারের হস্তান্তর ও ডিভিডেন্ড পেমেণ্টের বিরুদ্ধে বিশেষ নিবেদন জারি হয়ে থাকে বা যেখানে এই প্রকার শেয়ার আমানত (ডিপোজিটারিজ) আইন 1996-এর আওতায় প্রতিশ্রুতিবদ্ধ বা অনুমিত, সেক্ষেত্রে ব্যাঙ্ক IEPF কর্তৃপক্ষকে শেয়ার হস্তান্তরিত করবে না।

এছাড়া এই মর্মেও বিজ্ঞপ্তি জারি করা হচ্ছে যে, IEPF নিয়মের বিধান অনুযায়ী, প্রত্যেক শেয়ারহোল্ডারকে বিজ্ঞপ্তি দ্বারা সতর্কভাবে ব্যাঙ্ক/কেফিন টেকনোলজিস লিমিটেড [রেজিস্টার এবং ব্যাঙ্কের শেয়ার ট্রান্সফার এজেন্ট ('RTA')]-এ নথিভুক্ত তাঁদের সাম্প্রতিকতম ঠিকানাম অন্যান্য আরও অনেক কিছুর সঙ্গে IEPF কর্তৃপক্ষের কাছে হস্তান্তরিত হতে চলা শেয়ারের প্রাসঙ্গিক বিবরণাদি জানানো হয়েছে। এই শেয়ারহোল্ডারদের বিবরণ, যেমন এইসব শেয়ারহোল্ডারদের নাম এবং কোলিও নম্বর বা ডিপি আইডি - ক্র্যামেন্ট আইডি, ব্যাঙ্কের ওয়েবসাইট <https://bandhanbank.com/unclaimed-shares-এ> 'ইনভেস্টর রিলেশনস' বিভাগের অধীনেও লভ।

অতএব সংশ্লিষ্ট শেয়ারহোল্ডারদের তাঁদের অনাদায়ী বা দাবিহীন অর্থ 21শে জুলাই, 2023 বা তার পূর্বে দাবি করার জন্য অনুরোধ করা হচ্ছে, অন্যথায় তাঁদের শেয়ার, শেয়ার থেকে জমা পড়া লাভ সমেত, IEPF কর্তৃপক্ষের কাছে যথাযথ তারিখে হস্তান্তরিত করা হবে।

সংশ্লিষ্ট শেয়ারহোল্ডাররা, যারা বাস্তবিক রূপে শেয়ারের কপি রেখেছেন এবং যাদের শেয়ার IEPF কর্তৃপক্ষের কাছে হস্তান্তরযোগ্য, অনুগ্রহপূর্বক লক্ষ্য করুন যে 25শে জানুয়ারী, 2022 তারিখের সেবি (SEBI) সার্কুলার সহ পঠিত IEPF নিয়মানুযায়ী, তাঁরা IEPF অথরিটিকে হস্তান্তরের জন্য যে প্রকৃত শেয়ার সার্টিফিকেট(গুলি) রেখেছিলেন তার পরিবর্তে ব্যাঙ্ক তাঁদের নিশ্চিতকরণ পত্র ইস্যু করবে, এবং উল্লেখ্য প্রকৃত শেয়ার সার্টিফিকেট(গুলি) স্বয়ংক্রিয়ভাবে বাতিল বলে বিবেচিত হবে। নিশ্চিতকরণ পত্র ইস্যু হওয়ার পর ব্যাঙ্ক আমানত বা ডিপোজিটারিকে কর্পোরেট কার্যাবলির মাধ্যমে জ্ঞাত করবে শেয়ার সার্টিফিকেট(গুলি)-কে ডিম্যাট আকারে রূপান্তরিত করতে এবং সেগুলিকে IEPF অথরিটির পক্ষে হস্তান্তরিত করতে। এতদ্ব্যতীত, ডিম্যাট মোডে থাকা শেয়ারগুলির ক্ষেত্রে, শেয়ারগুলি IEPF অথরিটিকে হস্তান্তরিত করতে সংশ্লিষ্ট আমানত বা ডিপোজিটারিকে কর্পোরেট কার্যাবলির মাধ্যমে প্রয়োজনীয় নির্দেশ জারি করে সরাসরি হস্তান্তর কার্যকর করা হবে। সংশ্লিষ্ট শেয়ারহোল্ডাররা, অনুগ্রহপূর্বক আরও লক্ষ্য করুন যে এইসমস্ত শেয়ারগুলি থেকে প্রাপ্ত ভবিষ্যৎ লাভও IEPF অথরিটিকে হস্তান্তরিত করা হবে।

**આ નોટિસ,** ઈન્વેસ્ટર એજ્યુકેશન એન્ડ પ્રોટેક્શન ફંડ ઓથોરિટી (એકાઉન્ટિંગ, ઓડિટ, ટ્રાન્સફર અને રીફંડ) રૂલ્સ, ૨૦૧૬, કોર્પોરેટ બાબતોનાં મંત્રાલય દ્વારા સમયાંતરે સંશોધિત અને જારી કરાતા જુદા જુદા પરિપત્રો (સામૂહિકરૂપથી આઈઈપીએફ રૂલ્સ તરીકે ઉલ્લેખ)ની જોગવાઈઓ અનુસાર આપવામાં આવે છે.

આ સાથે એ નોંધવામાં આવે કે ગૃહ ફાઇનાન્સ લિમિટેડ (ગૃહ)નાં બંધન બેંક લિમિટેડ (બેંક) સાથે ૧૭ ઓક્ટોબર, ૨૦૧૯થી થયેલાં જોડાણને અનુસરીને અગાઉનાં ગૃહ દ્વારા જાહેર કરવામાં આવેલાં ડિવિડન્ડને લગતા બધા જ દાવાઓ બેંક સાથે કરવાના રહેશે.

આઈઈપીએફ નિયમો સાથે કંપની એક્ટ, ૨૦૧૩ની કલમ ૧૨૪ (૬)ની જોગવાઈના સંદર્ભમાં શેરધારકે સળંગ સાત વર્ષ કે તેથી વધુ સમય માટે ડિવિડન્ડ માટે દાવો ન કર્યો હોય તેવા શેર બેંક ઈન્વેસ્ટર એજ્યુકેશન એન્ડ પ્રોટેક્શન ફંડ ઓથોરિટી (આઈઈપીએફ)નાં ડિમેટ એકાઉન્ટમાં ટ્રાન્સફર કરવા જરૂરી છે. તે મુજબ નાણાકીય વર્ષ ૨૦૧૫-૧૬ માટે અને ત્યારથી જે ઈક્વિટી શેર્સનાં ડિવિડન્ડનું જુલાઈ ૨૧, ૨૦૨૩ સુધી ચુકવણું થયું ન હોય કે તેનો દાવો કરવામાં આવ્યો ન હોય, તેને આઈઈપીએફ ઓથોરિટીને ટ્રાન્સફર કરવામાં આવશે. જો કે, જ્યાં કોઈ કોર્ટ અથવા ટ્રિબ્યુનલ અથવા વૈધાનિક સત્તાધિકારીનો ચોક્કસ આદેશ હોય કે જ્યાં આવા કોઈ પણ શેરના કોઈ પણ ટ્રાન્સફર અને ડિવિડન્ડની ચુકવણી પર રોક હોય અથવા જ્યાં આવા શેરડિપોઝિટરીઝ એક્ટ, ૧૯૯૬ની જોગવાઈઓ હેઠળ ગીરવે મૂકવામાં આવ્યા હોય અથવા અનુમાનિત કરવામાં આવ્યા હોય, ત્યાં બેંક આવા શેરને આઈઈપીએફ ઓથોરિટીને ટ્રાન્સફર કરશે નહીં.
