- The above Structure is valid from 1st NOV 2022 till 31st DECEMBER 2022
- Only AMFI registered distributors empanelled with SBI Funds Management Ltd are eligible for above Brokerage structure

B-30 incentive would be dependent upon the accrual on inflows from retail Investors. Therefore, B30 incentive shall be completely clawed back in case the investment is redeemed / Systematically Transferred /Switched out to another scheme / Switched out to the Direct Plan within Tyear of investment. B30 Incentive will be completely recovered / clawed back from the future brokerage payments. This applies even for the exit load free period (within the applicable claw back period of 1 year) mandated due to changes in fundamental attributes of the scheme.
- In case of any regulatory change or management decision with respect to expense ratio or reduction in TER due to increase in scheme size the brokerage structure will be tweaked accordingly from the date of change.
