

Terms and conditions for debit card offers

- 3. Bandhan Bank reserves the right to discontinue the Offer or any aspect thereof without assigning any reasons and/or without any prior intimation.
- 4. Bandhan Bank reserves the right to change eligibility criteria for the Offer or any aspect thereof, notwithstanding the aforementioned criteria at its sole discretion without any notice to the Customer/s.
- Bandhan Bank reserves the right to disqualify the Customer/s from the benefits of the Offer, if any fraudulent activity is identified as being carried out for the purpose of availing the benefits under the said Offer or otherwise.
