Pursuant to the provisions of Section 124(6) of the Companies Act, 2013 read with Rule 6 of the Investor Education and Protection Fund Authority (Accounting, Audit, Transfer and Refund) Rules, 2016, as amended, Equity Shares in respect of which dividend has not been claimed for seven consecutive years or more shall be transferred to Investor Education and Protection Fund ('IEPF'). NOTICE TO SHAREHOLDERS

(For Transfer of Equity Shares of Bandhan Bank Limited to Investor Education and Protection Fund)

NOTICE is hereby given in compliance with the provisions of the Investor Education and Protection Fund Authority (Accounting, Audit, Transfer and Refund) Rules, 2016, as amended, and various circulars issued thereto, from time to time, by the Ministry of Corporate Affairs (collectively referred as 'IEPF Rules')

Further, it may be noted that pursuant to the amalgamation of GRUH Finance Limited ('GRUH') into and with Bandhan Bank Limited (the 'Bank') with effect from October 17, 2019, all the claims relating to dividend declared by erstwhile GRUH shall be made with the Bank.

In terms of the provisions of Section 124(6) of the Companies Act, 2013, read with IEPF Rules, the Bank is required to transfer all shares, in respect of which, dividend has not been paid or claimed for seven consecutive years or more, to the demat account of the investor Education and Protection Fund ('IEPF') Authority. Accordingly, equity shares in respect of which, dividend declared for the financial year 2015-16 and onwards remains unpaid or unclaimed till July 21, 2023 shall be transferred to the IEPF Authority. However, where there is a specific order of any Court or Tribunal or Statutory Authority restraining any transfer of such shares and payment of dividend or where such shares are pledged or hypothecated under the provisions of the Depositories Act, 1996, the Bank will not transfer such shares to the IEPF Authority.

NOTICE is further given that in accordance with the provisions of the IEPF Rules, individual notices have already been sent to the concerned shareholders, at their latest addresses available with Bank/KFin Technologies Limited (the Registrar and Share Transfer Agent ('RTA') of the Bank), inter alla, providing relevant details of shares due to be transferred to the IEPF Authority. The details of such shareholders, such as, names of such shareholders and their follo number or DP ID-Client ID, is also available on the website of the Bank under the section 'Investor Relations' at https://bandhanbank.com/unclaimed-shares.

The concerned shareholders are, therefore, requested to claim the unpaid or unclaimed dividend(s) on or before July 21, 2023, failing which, their shares, along with the benefits accruing on such shares, will be transferred to the IEPF Authority.

The concerned shareholders, holding shares in physical form and whose shares are liable to be transferred to IEPF Authority, may please note that in terms of the IEPF Rules read with SEBI Circular dated January 25, 2022, the Bank would be issuing Letter of confirmation in lieu of the original share certificate(s) held by them for the purpose of transferring the said shares to IEPF Authority and the said original share certificate(s) shall automatically stand cancelled. After issue of Letter of Confirmation, the Bank will inform the depository by way of corporate action to convert such physical share into DEMAT form and transfer in favour of the IEPF Authority. Further, in case of shares held in demat mode, the transfer would be effected by way of a corporate action to be executed with the concerned depository with necessary instruction to transfer such shares directly to IEPF Authority. The concerned shareholders are further requested to note that all future benefits arising on such shares would also be transferred to the IEPF Authority.

It may further be noted that post transfer of shares and dividend to IEPF Authority, the concerned shareholder may claim the shares and dividend so transferred from the IEPF Authority by making an online application in the prescribed Web based e-Form IEPF-5 and thereafter, sending the physical copy of the same, duly signed (as per the specimen signature recorded with the Bank), along with requisite documents as enumerated in the e-Form IEPF-5 and IEPF Rules, in original, to the Bank/RTA at the addresses mentioned below. The Shareholder are requested to refer the procedure prescribed under the IEPF Rules or visit website of IEPF authority at www.lepf.gov.in.

સંબંધિત શેરધારકો, જેઓ ફિઝિકલ શેર ધરાવતા હોય અને જેમના શેર આઇઇપીએફ ઓથોરિટીને ટ્રાન્સફર કરવાના થતા હોય, તેઓ કૃપા કરીને નોંધ લેશો કે આઇઇપીએફ નિયમોની શરતો અને તેને સેબી પરિપત્ર જાન્યુઆરી રૂપ, રૂ૦ રૂ૨ની સાથે વાંચતાં તે અનુસાર, બેંક શેર આઇઇપીએફ ઓથોરિટીમાં ટ્રાન્સફર કરવાના હેતુસર, તેમનાં મૂળ શેર પ્રમાણપત્ર(ત્રો)ને બદલે લેટર ઓફ કન્ફર્મેશન જારી કરશે અને મૂળ શેર પ્રમાણપત્ર(ત્રો) આપમેળે રદ થઇ જશે. નવા લેટર ઓફ કન્ફર્મેશન જારી કરાયા પછી, બેંક શેર પ્રમાણપત્ર(ત્રો)ને કિમેટ ફોર્મમાં રૂપાંતરિત કરવા અને ઓથોરિટીની તરફેણમાં ટ્રાન્સફર કરવા માટે કોર્પોરેટ કાર્ચવાહી દ્વારા કિપોઝિટરીને જાણ કરાશે. વધુમાં, કિમેટ મોકમાં રાખવામાં આવેલા શેરના કિસ્સામાં, આવા શેરને સીધા આઇઇપીએફ સત્તાધિકારીને સ્થાનાંતરિત કરવા માટે જરૂરી સૂચના સાથે સંબંધિત કિપોઝિટરી સાથે અમલ કરવાની કોર્પોરેટ કાર્ચવાહી દ્વારા ટ્રાન્સફર થશે. સંબંધિત શેરધારકોને વધુ વિનંતી કરવામાં આવે છે કે તે નોંધે કે આવા શેર પર થતા તમામ ભાવિ લાભો પણ ઓથોરિટીને ટ્રાન્સફર કરવામાં આવશે.

વધુમાં એની નોંધ લેવામાં આવે કે આઇઇપીએફ ઓથોરિટીને શેર અને ડિવિડન્ડ ટ્રાન્સફર કર્યા પછી, સંબંધિત શેરધારક આ ટ્રાન્સફર કરેલા શેર અને ડિવિડન્ડ માટે દાવો કરી શકે છે, ઓનલાઇન વેબ આધારિત ઇ–ફોર્મ આઇઇપીએફ–૫ દ્વારા અરજી કરી શકે છે અને તેની યોગ્ય રીતે હસ્તાક્ષર કરેલી ફિઝિકલ કોપી (બેંક સાથે નોંધાયેલા નમૂનાના હસ્તાક્ષર મુજબ) જરૂરી દસ્તાવેજો કે જે વિશે ઇ–ફોર્મ આઇઇપીએફ– ૫ અને આઇઇપીએફ રૂલ્સમાં વિગતે જણાવાયું છે તે મુજબ, તેની અસલ સિંદત બેંક/આરટીએને મોકલી શકે છે. શેરધારકને આઇઇપીએફ નિયમો હેઠળની પ્રક્રિયાનો સંદર્ભ લેવા અથવા આઇઇપીએફ ઓથોરિટીની વેબસાઇટ www.iepf.gov.in ની મુલાકાત લેવા વિનંતી છે.
