This is to inform that a Meeting of the Board of Directors of Bandhan Bank Limited (the 'Bank') is scheduled to be held on Friday, October 25, 2024, at Kolkata, to, inter alia, consider and approve the Unaudited Financial Results of the Bank for the quarter (Q2) and half-year ended September 30, 2024.

Pursuant to the provisions of the SEBI (Prohibition of Insider Trading) Regulations, 2015 and the Bank's Code of Conduct for Prevention of Insider Trading and Code of Practices and Procedure for Fair Disclosure of Unpublished Price Sensitive Information, the Bank has already informed the Stock Exchanges, vide its letter no. BBL/274/2024-25 dated September 26, 2024, that the window for trading in securities of the Bank for its Promoter(s), Member(s) of the Promoter Group, Directors, Designated Persons, Auditors and their immediate relatives, and Connected Persons shall remain closed from October 01, 2024 till the expiry of 48 hours after the declaration of the Unaudited Financial Results for the quarter (Q2) and half-year ended September 30, 2024 and shall re-open thereafter. Accordingly, the trading window shall reopen 48 hours after the declaration of the said financial results.

Further, please also be informed that post declaration of the aforesaid Unaudited Financial Results, the Bank will host an earnings call (i.e., group call) with analysts and investors on the quarterly performance on Friday, October 25, 2024. Details of the said earnings call are enclosed.
